<b>Agreement/conflict level</b>	Intrastate/intrastate conflict <b>Nicaraguan Revolution (1978 - 1979) and Sandinista/Contra War (1981 – 1990)</b>  The Nicaraguan Revolution was launched in 1978 by the left-leaning Sandinista National Liberation Front (FSLN) and aimed at overthrowing the dictatorship of Anastasio Somoza. Although initially successful at overthrowing the regime in 1979, the Sandinistas faced growing a back-lash from the U.S.-backed right-wing Contras. Resistance also came from ethnic minorities along the Mosquito Coast. The following civil war was marked by mass human rights atrocities on both sides, with mass disappearances of those placed in state-custody, and mass rape and murder by rebels to ensure local complacency. The war eventually came to an end in 1990 when the FSLN peacefully transferred power after losing the 1990 election. Close Nicaraguan Revolution (1978 - 1979) and Sandinista/Contra War (1981 – 1990)
