The Suspension of Operations (SoO) agreement is a ceasefire pact established on August 22, 2008, between the Government of India, the Government of Manipur, and two umbrella organizations representing various Kuki militant groups: the United People's Front (UPF) and the Kuki National Organisation (KNO). The primary objective of this agreement was to facilitate a political dialogue aimed at addressing the Kuki insurgency in Manipur.
