A joint meeting of the Sub-Committees on Cessation of Hostilities of the Government of the Republic of the Philippines (GRP) and the Horo Islamic Literation Front (MILF) was held at the Da'sah Center, Crossing Simmay, Sultan Kudarat, Haguindanao on Harch 23-25, 1997.

In this joint meeting, the two Sub-Committees have agreed to convene the Interim Ceasefire Honitoring Committee (ICMC) as previously agreed in the second meeting of the Technical Committee of the GRP and the MILF on February 25-27, 1987.


- It was agreed by both Sub-Committees that the composition of the Interim Ceasefire Honitoring Committee shall be as follows:
 - 1. Representative of Notre Dame University (NDU)
- 2. Representative of Maguindanaon Professionals and Employees Association (MAPEA), Inc.
- 3. Representative of Protestant Lauyers League of the Philippines (PLLP)
- 4. Representative of Cotabato City Media Multi-Purgose Cooperative (CCMPC).

Letters of invitation will be served to the above-mentioned organizations/institutions for their availability and acceptance.

It was agreed further that the NDU representative shall set as Chairman of the Interim Ceasefire Honitoring Committee, with the MAPEA representative as Vice Chairman.

The Interim Commercian Committee shall function under the following terms:

- a) Conduct fact-finding inquiries on matters referred to it by the GRP and MILF Sub-Committees on Cassation of Hostilities pertaining to alleged violations/infractions of the provisions of the Interim Commenter Agreement entered into by both Sub-Committees on January 27, 1997. Referrals shall be made after the other party is duly informed of the matter submitted for inquiry, and the same is not resolved by the Sub-Committees thereof.
- b) Issue appropriate letters of invitation to persons whose declarations/statements may read light on matters under consideration by the Interim Ceasefire Honitoring Committee.
- c) Coordinate with other offices and/or organizations as may be necessary in the exercise of its functions/tasks.
- d) Prepare and submit reports duly supported by appropriate evidence on matters which may be referred to it by the GRP and the MILF Sub-Committees on Consultion of Hostilities.
- e) Conduct its inquiries and submit reports to the GRP and the HILF Sub-Committees of Committees of Hostilities with utmost dispatch.
- f) All reports and proceedings of the Interim Ceasefire Monitoring Committee shall be considered classified. No part of it nor information thereof maybe divulged to anyone, except by the authorized official spokespersons of the GRP and the MILE as provided for in the Administrative Proceedures in the Conduct of GRP-MILF Technical Committee Muetings adopted on February 25, 1997.





- g) Additional membership to the Interim Commetite Monitoring Committee maybe made upon Joint approval by the COP and the MILF Sub-Committees on Cossation of Hostilities.
- h) The Interia Conseive Honitoring Countities chall adopt such internal procedures as maybe appropriate to camble it to expeditiously perform its tasks and submit the same to the CMP and Hilf Sub-Countities on Conseive of Northities for its Joint motation and approval.
- 1) The Interim Consefire Homitoring Committee may employ the expertise of certain disinterested persons or organizations in the pursuance of its assigned tasks.
- j) Perform such other acts as maybe jointly determined to be necessary by the GRP and the MilF Sub-Counittees on Counties of Hostilities for the accomplishment of its tests/Eunetics.

The CRP and the HILF shall, within its capabilities, provide administrative support to the Interim Conselled Healtoning Consistes in the performance of its functions.

The two Sub-Committees on Cossetion of Hostilities shall submit the points of agreement in this joint meeting for final confirmation and approval to the Third Hosting of the Tuchmical Committee of the GRP and the HILF on April 9-18, 1997 at the Notre Dema University in Cotabato City.
