THIS ACKNOWLEDGEMENT SHALL BE SUBJECT TO THE FOLLOWING

- A. THAT THE SIZES OF THE ABOVE-MENTIONED CAMPS/POSITION SHALL BE LIMITED TO THOSE AREAS WHERE THE MILF FORCES ARE
- B. THAT THE EFFECTIVITY OF THIS ACKNOWLEDGEMENT SHALL BE FOR THE DURATION OF THE GRP-MILF PEACE TALKS;
- C. THAT ALL CONCERNED GOVERNMENT AGENCIES CONSULTED IN THE VERIFICATION PROCESS OF SAID AREAS, AND
- D. POLICE AND MILITARY ACTIONS AND ADMINISTRATIVE ACTIVITIES SHALL CONTINUE TO BE UNDERTAKEN BY THE GRP THROUGHOUT MINDANAO AND THE ENTIRE COUNTRY. IN PURSUIT THEREOF, CONFRONTATIONAL SITUATION BETWEEN THE GRP AND MILF FORCES SHALL BE AVOIDED BY PRIOR COORDINATION WITH THE LATTER.
